



# COMED BILL CHANGES FOR CUSTOMERS

You will see two new changes on your ComEd bill related to energy efficiency because of a new law called the Future Energy Jobs Act (FEJA).

These changes under FEJA will help pivot Illinois to the new clean energy economy, creating significant consumer and environmental benefits, creating thousands of clean energy jobs, and providing job training for the future workforce.

The sample bill below shows the two line item changes you can expect to see.

## EXPLANATIONS OF THESE REQUIRED LINE ITEMS

### Energy Efficiency Programs

This line item funds new and expanded energy efficiency programs that can help ComEd customers save energy and money. The passage of the Future Energy Jobs Act helped to reduce this charge from the prior \$2/month average.

### Energy Efficiency Credit

A credit to customers for energy efficiency program charges that were collected from June 2016 - April 2017, but not utilized.

**NOTE:** These are representative numbers for an average ComEd-supplied residential customer. Actual numbers will vary nominally.
