


RESIDENTIAL AND SMALL COMMERCIAL ELECTRIC CUSTOMERS

AVAILABLE TO BOTH RESIDENTIAL AND SMALL COMMERCIAL CUSTOMERS

Rate BES Basic Electric Service

Basic electric service provided by ComEd including both supply and delivery (“bundled electric service”) for residential customers and nonresidential customers that have small electric loads (generally under 100 kW).

Rate RDS Retail Delivery Service

Electric delivery only service under which ComEd delivers electricity. Residential and nonresidential customers may elect to purchase unbundled electric supply from a Retail Electric Supplier. Only nonresidential customers, if eligible, may elect to purchase unbundled electric supply from ComEd.

Rate BESH Basic Electric Service Hourly Pricing

Bundled electric service for both residential and nonresidential customers in which charges for electric energy supply change on an hourly basis.

Rider NS Nonstandard Services and Facilities

Service facilities in addition to or different from standard facilities for which a one-time payment and/or monthly rental fee is charged.

Rider ML Meter-Related Facilities Lease

Metering in addition to or different from standard metering for which a monthly rental fee is charged.

Private Outdoor Lighting

Available to customers outside the City of Chicago for lighting private property from ComEd owned lights mounted on utility poles.

AVAILABLE TO RESIDENTIAL CUSTOMERS

Rider RRTP Residential Real-Time Pricing (RRTP) Program

RRTP is an optional market based pricing program for residential customers that use ComEd's Rate BESH to determine your monthly electric bills. With RRTP, you pay the hourly market price of electricity, which can vary hour to hour. Although savings cannot be guaranteed, you can potentially save money by voluntarily shifting electricity use to times when prices are lower, such as nights and weekends. Rider AC Residential Air Conditioner Load Cycling Program

Bill credit provided in the summer months to residential electric service customers that have electric central air conditioners and agree to allow cycling of such air conditioners during the summer months.

Rider PTR Peak Time Rebate (Peak Time Savings)

Residential customers whose homes have a smart meter and who voluntarily use less electricity during summertime Peak Time Savings Hours can earn a bill credit.

AVAILABLE TO SMALL COMMERCIAL CUSTOMERS

Rider VLR Voluntary Load Response and System Reliability Program

Compensation available to nonresidential customers that agree to curtail a minimum of 10 kW of the customer's load upon request from ComEd.
