The ComEd Electric Vehicles (EVs) For Education Program is available to public schools in the ComEd service territory that operate an internal Driver Education Program and meet other specific eligibility requirements as described in this document. The goals of the program are to introduce and familiarize tomorrow's drivers with new technology and to help mitigate three potential obstacles schools might face in integrating electric vehicles into existing Driver Education Programs, both behind the wheel and in the classroom: (1) the cost of Charging Equipment and Installation, (2) the higher incremental purchase price of Electric Vehicles, and (3) Classroom Education on Electric Vehicles. As part of the program, ComEd will collect participant's charging station data to analyze and better understand the charging habits of its customers.

The ComEd EVs For Education Program will provide assistance to schools that are accepted into the program. At its discretion, ComEd will provide: (1) funding towards the purchase and installation of one or more Level 2 (L2) Electric Vehicle Supply Equipment (EVSE, or commonly known as charging station), (2) funding towards the purchase of one or more new or used Electric Vehicle(s) (EV), and (3) assistance with supplemental educational material focused on teaching students about EV technology and how to operate an EV in an efficient and responsible manner.

The purpose of this Interest Indication Form is solely for ComEd to determine which schools have interest in and may be eligible for the program. This is not a commitment to service nor enrollment into the program. A separate application submission by the applicant and subsequent review by ComEd is needed to determine eligibility. Schools that express interest in the program by completing this form will be sent more information about the application process.

## EVS FOR EDUCATION PROGRAM REQUIREMENTS

To be eligible for the program, the public school is required to meet the following requirements:

1. Operate an internal Driver Education Program staffed by school district employees
2. Plan on obtaining a vehicle and charging station for their Driver Education Program
3. Have the ability to partner with an established nonprofit foundation or organization
4. Complete periodic surveys
5. Agree to provide charging station data to ComEd upon request
