LED Streetlights

Reduce energy and maintenance costs by upgrading streetlights to energy-efficient LEDs. The ComEd Energy Efficiency Program provides an incentive of 70 cents per watt reduced for converting streetlights owned by municipalities and other public sector entities to LEDs.

FREE MAPPING AND APPLICATION ASSISTANCE

ComEd provides FREE mapping and application assistance to help you take advantage of the streetlight incentive.

ComEd services include:

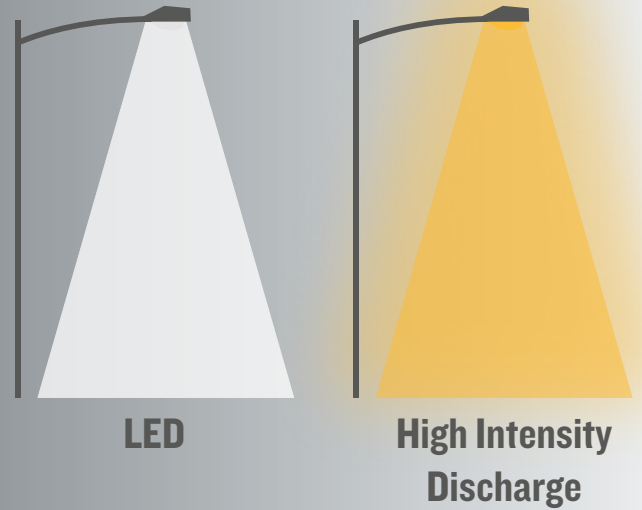
- » Guidance identifying eligible streetlighting projects

- » Project documentation and verification help
- » Pre-approval and final application assistance

- » Projects must replace public sector owned streetlights with LED fixtures.
- » Newly installed LED streetlights must be certified by the DesignLights™ Consortium. Visit DesignLights.org to find qualified products.
- » All projects must be pre-approved to receive incentives.
- » The incentive is available for projects completed between January 1 and December 31, 2020.
