## Commercial Appliances

### ENERGY STAR® Electric Steam Cooker

**\$1,500 per cooker**

New or replacement ENERGY STAR electric steam cooker.

**Specifications:**

1. Must be ENERGY STAR-qualified with a minimum cooking energy efficiency of 50 percent for all size units.
2. Used or rebuilt equipment is not eligible.

### Electric Combination Oven

**\$1,100 per oven**

New or replacement electric combination oven.

**Specifications:**

1. Must meet or exceed heavy load cooking energy efficiency of 60 percent utilizing ASTM Standard F2861.
2. Used or rebuilt equipment is not eligible.

### ENERGY STAR Convection Oven

New or replacement ENERGY STAR convection oven.

**Specifications:**

1. Must meet ENERGY STAR Version 2.0 Convection Oven specification.

## ENERGY STAR Hot Food Holding Cabinet

**\$320 per cabinet**

2. Cook-and-hold equipment is not eligible.
3. Used or rebuilt equipment is not eligible.

## ENERGY STAR Electric Griddle

New or replacement ENERGY STAR electric griddle.

### Specifications:

1. Must be ENERGY STAR-qualified with a minimum cooking energy efficiency of 65 percent for all size units.
2. Used or rebuilt equipment is not eligible.

## ENERGY STAR Electric Vat Fryer

**\$200 per fryer**

New or replacement ENERGY STAR electric vat fryer.

### Specifications:

1. Must be ENERGY STAR-qualified with a minimum cooking energy efficiency of 80 percent for all size units.
2. Used or rebuilt equipment is not eligible.

## Heat Pump Water Heater (Electric Only)

**\$250 per heater**

New or replacement heat pump water heater with a nominal input of 12 kW (40,956 Btu/h) or less, with a rated storage volume from 20 to 120 gallons.

### Specifications:

1. Must have energy factor  $\geq 2.2$  and first hour rating (FHR)  $\geq 55$  gallons per hour.
2. Add-on heat pump water heaters are also eligible.
3. Electric water heaters outside of this range and tankless water heaters may qualify for custom incentives.

## Electric Water Heater Timer

**\$20 per timer**

Installation of a schedulable timer on a new or existing electric water heater.

### Specifications:

1. The timer must shut down the water heater at least 14 hours per week.
2. The water heater must be electric and at least 60 gallons.

## High Efficiency Pre-Rinse Spray Valve

**\$28 per spray valve**

New or replacement pre-rinse spray valve with a flow rate of 1.6 gallons per minute or less.

### Specifications:

1. Must have a cleanability performance of 26 seconds per plate or less, based on ASTM standard test method.
2. This measure is only applicable for systems with electric storage water heaters.

## Reach-in (Novelty) Cooler and Beverage Machine Controls

### Specifications and Eligible Equipment

1. Controls must include a passive infrared occupancy sensor to turn off fluorescent lights and other vending machine systems when the surrounding area is unoccupied for 15 minutes or longer.
2. The control logic should power up the machine at two-hour intervals to maintain product temperature and provide compressor protection.
3. This measure does not apply to ENERGY STAR-qualified vending machines.

### Reach-in (Novelty) Cooler Controls

Installation of new controls on a new or existing glass-front refrigerated cooler.

### Beverage Machine Controls

**\$100 per machine**

Installation of new controls on a new or existing refrigerated beverage vending machine that contains only non-perishable bottled and canned beverages.

### Snack Machine Controls

Installation of new controls on a new or existing non-refrigerated snack vending machine with existing lighting.

### Specifications:

1. Controls must include a passive infrared occupancy sensor to turn off fluorescent lights and other vending machine systems when the surrounding area is unoccupied for 15 minutes or longer.

### ENERGY STAR Refurbished Vending Machine

Installation of ENERGY STAR Tier II refurbishment kit.

## ENERGY STAR Ice Makers

1. Only air-cooled, cube-type machines including ice-making head, self-contained and remote-condensing units, qualify. This measure excludes flake and nugget-type ice machines.
2. The ice maker must be ENERGY STAR-qualified.

## ENERGY STAR Commercial Clothes Washers

### Specifications and Eligible Equipment

1. If replacing, existing washer must have an MEF of < 2.2 (ft<sup>3</sup>/kWh/cycle).
2. New and replacement washer must meet ENERGY STAR criteria and must have a MEF of ≥ 2.2 (ft<sup>3</sup>/kWh/cycle).
3. Commercial clothes dryers are not eligible for this incentive.
4. Please check one of the following combinations for the washer water supply and clothes dryer fuel supply\*:
  - Electric hot water heater, electric dryer
  - Electric hot water heater, gas dryer
  - Gas hot water heater, electric dryer



\*Gas hot water heaters in conjunction with gas dryers are not eligible for incentives.

### ENERGY STAR Commercial Clothes Washers – Front Loaded

New or replacement ENERGY STAR front loaded electric commercial clothes washer.
